However, the **Vacant seats in Self Finance Institutes (SFI)** shall be filled as per provisions of rule 20 of prevailing notification. Accordingly all eligible candidates who are already in the merit list of the Admission Committee or those who have not registered earlier or if they have registered earlier but not appeared in Common Entrance Test of current year, conducted by the Admission Committee shall have to contact the concerned institute of his choice personally between **21-08-2019 to 26-08-2019** and apply for vacant seats admission process as per eligibility criteria of prevailing admission rules of Government of Gujarat.

The concerned self-finance institute shall process the filling up of vacant seats among such eligible candidates strictly in lines with all provisions of prevailing notifications of Government of Gujarat for admission to ME /MTech/MPharm courses.

The vacant seats details and its guidelines for filling in SFI institutes at institute level are available on committee's website. The detailed schedule for the vacant seats in SFI is as below.

1	Submission of application along with copies of requisite documents for all eligible candidates at SFI institute level for vacant seats participation.	21-08-2019 to 26-08-2019
2	Admission process such as merit preparation, counselling etc for all eligible candidates at SFI institute level.	27-08-2019 to 31-08-2019

In case of admission to SFI in vacant seats, the process for refund of fee for seat already allotted by this committee shall be as per rule 19 of prevailing notifications of Government of Gujarat for admission to ME/MTech/MPharm courses.
